

# CONSULTATION ON THE CLOSURE OF RANDAL CREMER PRIMARY SCHOOL

#### **Overview**

Hackney Council is consulting on a proposal to close Randal Cremer Primary School by **31 August 2024**. The closure is being proposed due to a fall in pupil numbers across primary schools in London. Fewer children in schools means less government funding for schools to operate, which over time, creates significant financial pressure on schools.

While our schools have achieved excellent results for their students, this income loss will make it increasingly challenging to maintain them in the long run.

The Council has the duty to provide high quality school places for all school aged children in the borough. Unless we act now, in time, the quality of education in the schools with falling rolls will be affected due to diminished access to resources and funding.

This document is part of a six-week public consultation, setting out the reasons for the proposal and seeking your views and comments about it. There are a number of ways you can respond to the consultation - these are set out at the end of this document. The closing date for responses is **Sunday**, **16 July 2023**. At the end of this consultation period, a decision to issue a statutory notice on the proposal will be taken by Hackney Council. This is likely to be in September or October of this year.

# Why is a closure being proposed?

There has been a significant fall in the number of primary age children in many parts of London, including Hackney. The reasons behind this are thought to include falling birth rates, lack of affordable housing for families, as well as Brexit and the recent pandemic. The fall in numbers together with reduced funding from central government, means some of our schools are facing major challenges. If we continue to allow schools to remain open with significant levels of surplus places, it will put schools at severe financial risk which could lead to sudden unplanned school closures or changes.

### **Randal Cremer Primary School**

The Council has been monitoring schools that have been most affected by falling pupil numbers and budget pressures. Randal Cremer has been affected by a fall in pupil numbers and loss of funding. At the start of September 2022, the school reduced its Reception PAN to 45 having previously admitted 60 each year. The following table shows the number of unfilled places for the last five years.

For entry to the school this September (2023), 16 reception offers have been made. There are 45 reception places available.

#### **School Funding**

Schools are funded by the government on a formula basis. Schools with unfilled places lose  $\pm 6,484$  per place, every year. The number of pupils attending a school drives the level of funding received. This means that schools with unfilled places are under increased financial pressure and, over time, are less able to function efficiently. Randal Cremer Primary School recently reduced its PAN from 60 to 45 in an attempt to provide stability for the school. However, regrettably, this will not allow the school to remain financially viable in the long term and it is for this reason that a closure is proposed.

The Council must ensure that Hackney schools are full or nearly full so that they can cope with ongoing financial pressures. We know that a potential closure will be a difficult and upsetting process for many, particularly the children, staff and community of Randal Cremer Primary School. We will provide support for the education choices and wellbeing of children and staff.

#### What school will children transfer to?

Closing Randal Cremer Primary School means that all children will be transferred to other schools. There are sufficient schools nearby with surplus places that could accommodate the pupils from Randal Cremer Primary School. We will support parents with transition arrangements to nearby local schools that have spaces, taking into consideration any issues and concerns raised by families.

# Are there any other school changes being proposed in Hackney?

We are also consulting on the proposed closure of De Beauvoir Primary School and the amalgamations of Baden Powell Primary School with Nightingale Primary School, and Colvestone Primary School with Princess May Primary School. This proposal forms a part of our longer term strategy for managing falling rolls.

# What will happen next?

We have been engaging with our schools and the community about school organisation changes since the beginning of this year. Comments, questions and feedback provided by parents and staff in engagement sessions at schools were recorded.

This stage of the process (the 'informal' consultation), will run from 5 June to 16 July 2023. The Council will consider all the views put forward during this consultation period and the engagement sessions before any decisions are made on the proposal.

# **Meetings**

Information sessions will be offered at Randal Cremer Primary School. This will be an opportunity for you to learn more about the proposal or to raise any concerns that you have regarding your child's education before or after the proposed closure. #### **Timeline**

Date	Event	
5 June -16 July 2023	Informal consultation	
September/October 2023	Results of the informal consultation are considered by Hackney Cabinet. A decision is made whether to publish a statutory notice for the closure of Randal Cremer Primary School.	
September/October 2023	Statutory notice published for a 4-week period.	
December 2023	The outcome of the statutory notice period and any objections are considered by the Cabinet and a final decision on the closure proposal is made.	
January - August 2024	School closure arrangements are carried out (subject to Cabinet's decision).	
31 August 2024	Randal Cremer Primary School officially closes.	
September 2024	Former pupils of Randal Cremer Primary School start at a new school.	

## **Summary**

- Hackney has experienced a fall in primary aged children requiring places. This means that schools' funding from central government has reduced.
- Randal Cremer Primary School has been affected by falling rolls and has a high number of surplus places.
- This proposal is to close Randal Cremer Primary School as a legal entity on 31 August 2024.
- Children currently on roll at Randal Cremer Primary School will be offered a place at another local school.
