**Re: Stage 2 Zone W Implementation**

Parking Services consulted all residents and businesses in the Parking Zone W area on a Stage 2 design consultation for the zone. The statutory consultation has now been completed, which means that the operational hours of **Monday to Friday 10.00am to 12(noon)** and a final parking design have been confirmed and will be implemented.

This letter provides details of the dates we will be marking out the parking restrictions on your road and when enforcement of these restrictions will begin.

### **How will the change affect me as a resident?**

Controlled parking will be introduced on all streets in Zone W, where the operational hours of **Monday to Friday 10.00am to 12(noon)** will be introduced.

All vehicles will need to have a valid ePermit, voucher or parking session in order to park on Zone W roads when parking enforcement commences.

## Key facts

<b>Purchasing of permits can commence from:</b>	<b>13 June 2022</b> You can start applying for your permit a month in advance of the go live date. Please see 'Applying for Permits and Vouchers' section below for further information.
<b>Temporary parking restrictions during lining works:</b>	<b>06 June 2022 to 23 June 2022</b> For the duration of the lining works please use the enclosed <b>Temporary Implementation Permit</b> to park in zones <b>E or G</b> . The permit will allow you to park in any on street resident, permit and shared use bays within each zone (please see attached terms and conditions). Your temporary permit will only be valid for the period of <b>06 June 2022 to 23 June 2022</b>  <b><u>Please note, this permit is only valid in existing Parking Zones E &amp; G. It cannot be used to park on suspended roads during lining works. Parking in suspended parking bays WILL result in being issued with a penalty charge notice.</u></b>
<b>Permit start dates:</b>	<b>11 July 2022</b> This is the start date of your permit. Please ensure that you enter this date when applying for your permit online.  If you currently hold a companion badge, please contact the parking permits team as the rules for eligibility have changed. You may not be entitled to a companion badge under the new policy change and once Zone W parking controls go live. <b>Parking enforcement on the parking bays commences:</b>	<b>11 July 2022</b> You must have a valid Zone W e-permit, voucher or parking session to park in your zone from this date.
<b>Yellow line enforcement</b>	All <b>existing</b> and <b>new</b> yellow lines within the zone will be enforced during and after the lining works are completed. <b>Please ensure you do not park on any single or double yellow lines or you will be issued with a Penalty Charge Notice (PCN).</b>

## Signage during lining works

Yellow signs will be erected to inform motorists of the dates when the lining works are taking place. You must not park on these roads on the dates shown, these signs will be removed once the work is completed so that parking is available again as quickly as possible. **(Please note, lining works will only be carried out between 8am and 4pm on the dates below. No works will be carried out during weekends).**

## IMPORTANT

To help us ensure that we can complete these works as quickly as possible, please move your vehicle to an alternative street in Zone E or G (using your Temporary Implementation Permit) or to a section of the road where works are not taking place and where there are no suspensions in place.

**Vehicles parked in the suspended roads during the specified dates above, WILL be issued with a PCN and relocated.**

Drivers who suspect their vehicle has been relocated should contact TRACE on 0300 077 0100 or via <https://trace.london/>

**Please note that dates of planned lining works may be subject to change due to a number of factors beyond our control. This includes weather conditions, covid guidance and whether or not roads have been kept clear of vehicles for works to be completed. Please check the yellow signs affixed to posts and lamp columns in the area for the most up to date information.**

## Parking in nearby zones during implementation

In order to provide you with alternative parking opportunities whilst lining works are taking place, you will be able to use the Temporary Implementation Permit (attached) to park in Zone E or G (enclosed map) between **06 June 2022 to 23 June 2022**. Please ensure that you do not park in Zone W after this date using the Temporary Implementation Permit, as you may be issued with a PCN.

The Temporary Implementation Permit cannot be used in any suspended roads during the lining works. **It is only valid in existing Parking Zone E & G. You will be issued with a penalty charge notice if you park on the suspended bays in Zone W during lining works.**

## Applying for permits and vouchers

You will need to have a valid parking permit or voucher to park on the street when the scheme goes live on **11 July 2022**. You can apply for these online by visiting [hackney.gov.uk/resident-permits](https://hackney.gov.uk/resident-permits) or by post from **13 June 2022**.

If you wish to park your vehicle on existing Zone E or G roads during the lining works, please ensure that you use the Temporary Implementation Permit between **06 June 2022 to 23 June 2022** only.

Permit start dates cannot be changed once they have been chosen and an application has been made. Full refunds will be made if they are cancelled before their start date. E-permits cancelled after the start date are payable for each full calendar month remaining on the permit from the date we receive your refund request. There must be a minimum of three months remaining on the permit and you will need to pay a £20 administration fee.

## Go Live

Parking enforcement on parking bays within Zone W will begin from **Monday 11 July 2022**.

From this date, all vehicles will need to display a valid epermit, visitor voucher or parking session when parking in Zone W during the operational hours of **Monday to Friday 10.00am - 12.00 (noon)**.

Parking controls will not be introduced on private roads. As a result, a Zone W permit is not required to park on these roads. A number of estates within Zone W may have their own parking controls which have different operational hours to Zone W. These estates require a different permit, you cannot therefore park on these estates with a Zone W on-street permit.
