



Parking Zone E and E Ext (Stoke Newington)

Consultation Outcome

Why have I received this summary booklet?

Parking Services consulted residents and businesses in the area between February and March 2018 to see whether the existing parking controls still suited local needs.

We would like to thank all those people who returned their questionnaire and provided feedback during the consultation. Your views are important to us and have helped shape the future of parking in your area.

We are pleased to announce that the consultation feedback has been reviewed and the final design has been approved by the Council. We will shortly commence signage works in the area to implement these changes pending statutory consultation.

This booklet provides a summary of the consultation results, final design of the parking restrictions for your area and dates of when the restrictions are likely to be implemented.

Parking Zone design changes

During the public consultation we sought your views on:

- The operational hours of parking controls in your zone
- Proposed bay changes in certain roads in the parking zone:

Parking Zone E and E ext renaming

As part of the review, Parking Services will merge Zone E together with E ext and rename it as Zone E, making it easier for motorists to understand the signage in the area. Current resident permits and vouchers will be valid in both zones.

Operational Hours

We asked your views on whether the current operational hours meet the needs of residents and businesses in the area and gave two options to choose from:

- **Option 1: Monday to Friday 8:30am to 6:30pm and Saturday 8.30am to 1.30pm.**
- **Option 2: Monday – Saturday 8:30am – 6:30pm**

89% of respondents answered this question, with the majority (68%) being in favour of Option 1, **Monday to Friday 8:30am to 6:30pm and Saturday 8.30am to 1.30pm.**

There were however, roads in the eastern section of Zone E and E ext. which were in favour of Option 2, Monday to Saturday 8.30am to 6.30pm. Feedback provided stated that those in favour of Option 2 suffered high parking stress on the weekends as a result of their close proximity to businesses on Stoke Newington High Street.

Final Recommendation

Based on the feedback received as well as to reduce traffic and air pollution in the area, we are recommending that the hours of operation in the majority of the roads to be changed to:

Monday to Friday 8.30am to 6.30pm and Saturday 8.30am to 1.30pm

With the exception of the following roads:

Batley Place, Batley Road, Bayston Road, Beatty Road, Brighton Road, Brooke Road, Darville Road, Evering Road, Garnham Street, Glading Terrace, Gunstor Road, Hollar Road, Jenner Road, Lawrence Buildings, Leswin Place, Leswin Road, Ormsby Place, Palatine Avenue, Sandford Terrace, Tysen Road, Victorian Grove, Victorian Road and Walford Road.

These roads will have their hours of operation changed to:

Monday to Saturday 8.30am to 6.30pm.

The recommended hours of operation reflect the differing needs of the area.

Parking Bay Changes

Parking Services proposed to change the existing resident and business permit bays throughout Zone E and E ext. to become permit holder only bays. The standardisation of signage will help reduce the cost of maintaining the parking bays throughout the zone. This change will have no effect on the permit holders in the area, as their permits will continue to be valid in both zones after they are merged and renamed.

Parking Services requested feedback on specific bay changes on some roads within both parking zones. The proposals highlighted in green in the table below received majority support and will be implemented. The remaining proposals which did not receive majority support or where support was split will not be implemented.

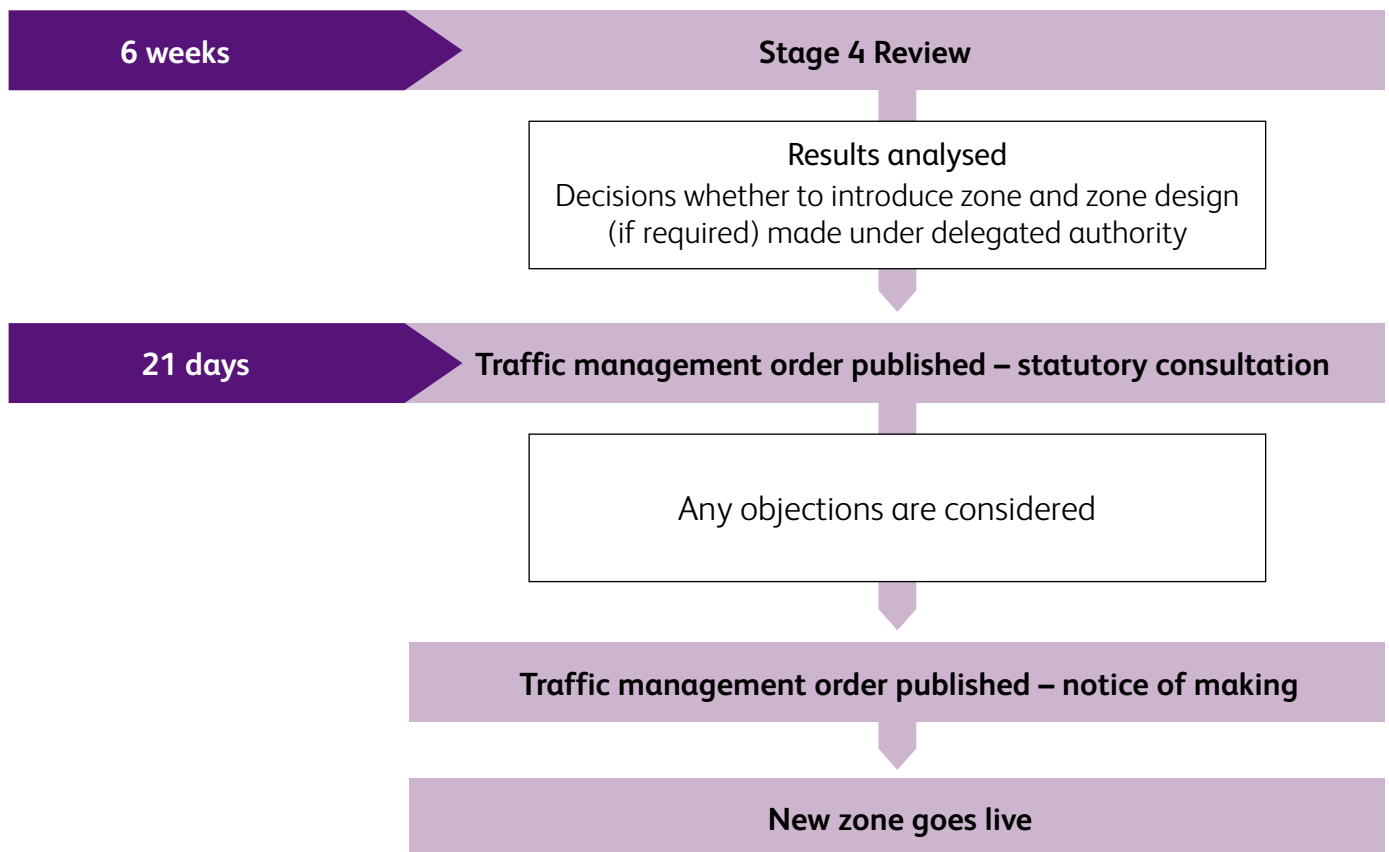

Statutory Consultation

Now the public consultation has been completed and recommendations have been approved, the Council is required to carry out a Statutory Consultation by publishing a Traffic Management Order notice in Hackney Today for a 21 day period. This process allows anyone to formally declare their representations on the proposed changes. All representations received as part of this process will be considered. The Council is then required to draft a decision audit report detailing the objections/ comments received and its recommendations on whether these objections/comments will be upheld or not. The report is then approved by the Director of Public Realm prior to the measures being implemented.



The proposed Traffic Management Order will be published in Hackney Today on **29 April 2019** and the statutory consultation closing date will be **20 May 2019**. All feedback must be received by the Council no later than 5pm **Monday 20 May 2019**. Any feedback received after this deadline will not be considered.

Parking Restrictions Implemented

As the proposed changes do not include any lining works, we expect all sign changes in the area to take place between **24 June 2019 to 1 July 2019**. Please ensure you adhere to the signs once they have been changed.

Please be advised that any vehicle parked within the bays whilst the signs are being changed will not be enforced on until the start of the next day.

Parking Permit and Vouchers

All existing Zone E ext. resident e-Permits and Companion Badges will be automatically updated and will be valid in zone E once the parking controls come into force.

Zone E ext. business permit holders do not need to take any action as these permits will be converted to an e-Permit and will also be automatically updated as soon as the parking controls come into force. Please discard any paper business permits you may have as these will no longer be valid.

Visitor Vouchers

Zone E and E ext. vouchers will continue to be valid in zone E after the changes have been made.

Frequently Asked Questions

E-permits

The Council has now introduced e-permits which means that resident permits and companion badges are now electronic, so if you are applying for a new permit or renewing your permit, you will not receive or need to display a paper permit on your vehicle. An e-permit becomes active for your vehicle from the date you select in your application. Once the permit has been purchased, our enforcement officers can check if a vehicle has a valid permit by entering the vehicle registration number into their hand held devices.

Visitor vouchers will remain as paper permits until further notice and will continue to be delivered by courier.

How much does a parking permit cost?

The way we charge for parking has changed over the past three years as part of a drive to reduce pollution and improve air quality. The pricing of permits now reflect the level of vehicle emissions instead of engine size. This means that parking permits are cheaper for low emission vehicles and for more polluting vehicles the charges are higher. Other changes include:

- Cars built before 2001 will move up a band in the charging scheme, reflecting the levels of CO2 they produce.
- Diesel vehicles will incur a £50 levy, which represents the high levels of particulate matter they produce.

The diesel supplement will be £50 per year, and will be pro-rated for 3 and 6 month permits.

*Where no information is held on a vehicle's CO2 emissions, permit price will be calculated on engine size.

Visitor Permits

Residents are eligible to purchase visitor vouchers which allow visitors to park in any available resident permit, general permit (resident or business permits) or shared use (pay and display or permit) bay in the parking zone (PZ).

You only need to use a voucher during operational hours. There are two types of vouchers available for purchase by residents:

- A book of 20, 2hr scratch cards at a cost of £23
- A book of 5, one day scratch cards at a cost of £20

Businesses are also able to buy vouchers for their own vehicles and their visitors, which cost £225 for a book of 10 scratch cards which allow parking in all zones for one day. We also provide Pay & Display parking for businesses visitors wherever possible.

Where can I load and unload if I receive deliveries?

Active loading and unloading can take place on all single and double yellow lines where there are no loading restrictions and also in parking bays. For any specific requests, such as removals, you can request a dispensation or the suspension of a parking bay.

How can I apply for a disabled bay?

If you are a Blue Badge holder with no access to off street parking, you may be eligible for a disabled parking bay installed outside your home. However, in order to qualify for a bay, there is a set criteria which you need to meet including an assessment by Social Services.

Although a disabled parking bay is registered to an individual once installed, it can be used by any Blue Badge holder as the bay is not personalised.

What if I have a Blue Badge or a Companion Badge?

Blue Badge holders are eligible to park in all shared use bays (pay and display and permit) and pay and display only bays for an unlimited amount of time and on single and double yellow lines for a maximum of 3 hours, providing there are no loading restrictions in place and that the vehicle is not causing an obstruction. Blue Badge holders may also use any disabled bay.

Companion badge holders can park in the same bays as Blue Badge holders, but have the added advantage of being able to park in resident and permit parking bays within their home parking zone. For more information on Companion Badges please visit

What if I own a motorcycle?

Motorcycles may be parked free of charge in all bays within a PZ where residents and businesses can park. This excludes Zone B where motorcycle parking is restricted to motorcycle bays only and pay and display bays within all zones.

Motorcycles should be parked at a right angle to the kerb and, if possible at the end of the parking bay. Dedicated motorcycle bays should be used if available, rather than resident permit bays.

What if I live on a Car Free Property?

A Car Free Property will be designated under a Section 106 agreement and will be included in your lease or deeds. If you live on a Car Free Property you can still have your say on the design and hours of your parking zone but you are not eligible to purchase a parking permit. You are however, eligible to purchase visitor vouchers for your visitors.

Please ensure that you check the car free status of your property before applying for a permit. Information regarding the car free status of your property can be found in your lease or purchase contract.
