Further to the consultation summary leaflet we sent to you in February 2017 about the introduction of parking controls in Zone S, we are writing to inform you of the dates that the lining and sign works are taking place on your street.

Please see table below for exact dates when parking in your street and surrounding streets in your area will be suspended whilst the lining works are being carried out. This means that residents will not be able to park on these street during the dates specified below (dates do not include weekends). Signs will be erected on each street to inform motorists of the dates of the lining works.

completed. Please check the yellow signs affixed to lamp columns in the area for the most up to date information.

We aim to complete these works as quickly as possible and with minimum disruption. To ensure that we can do this, please help us by moving your vehicle to an alternative street where works are not taking place.

Once we have completed the lining works on a section of road, the yellow suspension signs will be removed so that parking on the street will be available again.

Vehicles parked in suspended bays may be issued with a Penalty Charge Notice and removed to allow us to complete our planned works. Drivers who suspect their vehicle has been removed should contact TRACE on 0845 206 8602.

We recognise the inconvenience that lining works could cause you and as a result we have put in place arrangements to try to minimise disruption as much as possible.

In order to provide you with alternative parking opportunities whilst the lining works are taking place, residents and businesses can purchase a zone S permit from **10**<sup>th</sup> **April 2017**, in advance of lining work beginning. The permit will allow you to park in the adjacent Zone S whilst works are being carried out on your street. Please ensure that you display your new permit clearly in order to park in Zone S.

## Go Live Date

We aim to begin enforcement in the Zone S displacement area from the 19<sup>th</sup> June 2017. From this date, all vehicles will need to display a valid permit in order to park in the area during the hours of operation.
