Zone T implementation letter

Further to the consultation summary leaflet we sent to you in October 2017 about the introduction of parking controls in Zone T, we are writing to inform you of the dates that the lining and sign works will be taking place on your street, and the zone's go-live date.

Go Live Date

We aim to begin enforcement in the Zone T area from **8 January 2018**. From this date, all vehicles will need to display a valid permit in order to park in the area during the hours of operation.

Warning notices will be issued to vehicles parked in the area without a permit between the 2 January 2018 and 5 January 2018.

Street Parking Suspension dates

Please see table below for exact dates when parking in your street and surrounding streets in your area will be suspended whilst the lining works are being carried out. This means that residents will not be able to park on the streets during the dates specified below **(roads will only be suspended between 8am and 4pm on the dates below and will not be suspended on**

weekends). Signs will be erected on each street to inform motorists of the dates of the lining works.

***Suspensions dates may be subject to change due to a number of factors beyond our control. This includes weather and whether or not roads have been kept clear of vehicles for works to be completed. Please check the yellow signs affixed to lamp columns in the area for the most up to date information.**

We aim to complete these works as quickly as possible and with minimum disruption. To ensure that we can do this, please help us by moving your vehicle to an alternative street where works are not taking place.

Once we have completed the lining works on a section of road, the yellow suspension signs will be removed so that parking on the street will be available again as quickly as possible.

Be aware that vehicles parked in suspended bays may be issued with a Penalty Charge Notice (PCN) and removed to allow us to complete our planned works. Drivers who suspect their vehicle has been removed should contact TRACE on 0845 206 8602.

Applying for permits and vouchers

You will need to have a valid permit or vouchers to park in Zone T when the zone goes live. You can apply for these online or by post from **Monday 20 November 2017**.

When applying, please ensure that you enter a start date of **Monday 8 January 2018** and display your new permit clearly in order to park in Zone T.

Be aware that permit start dates cannot be altered once they have been chosen and an application has been made. Full refunds will be made if they are cancelled before their start date.

Parking in Zone R while roads are suspended

In order to provide you with alternative parking opportunities whilst lining works are taking place, you will be able to use your Zone T permit as soon as it arrives (and before its start date) to park in the existing Zone R (located south of Northwold Road), so that you don't have problems finding somewhere to park when your roads are suspended for lining works. **(Please see enclosed with this letter a map of zone R where your zone T permits will be valid to park until the 8 January 2018).**

Your permit will only be valid in Zone R until your zone goes live on the 8 January 2018. Please ensure that you do not park in Zone R after your

parking zone goes live as you may be issued with a PCN. Zone T visitor vouchers will not be valid in Zone R at any time.
