Zone U - implementation letter

Further to the consultation summary leaflet we sent to you in June 2018 about the introduction of parking controls in zone U, we are writing to inform you of the dates that the lining and sign works will be taking place on your street, and the zone's go-live date.

Key facts

- **Parking in the area will be suspended: between 10 and 28 September 2018.**
- **Parking enforcement in bays commences from: Monday 15 October 2018.**
- **Zone U permits can be purchased now.**
- **Starting your permit:** When applying, please ensure that you select the earliest available start date – **from this date until your new zone goes live** you will be able to park in zones R or T while lining works are carried out. Depending on the duration you bought, we will then extend your zone U e-permit to give you a full three, six or 12 months of parking from your new zone's start date at no extra cost to you.

IMPORTANT: Please be aware that we will have all relevant traffic orders in place for the commencement of the lining works and will be enforcing 'no waiting' (yellow line) restrictions from the time they are marked on the street. Please ensure you do not park on any single or double yellow lines or you may be issued with a Penalty Charge Notice (PCN)

Go live date

Parking enforcement in the zone U area will begin from **Monday 15 October 2018**.

From this date, all motorists will need to have a valid e-permit, display a valid visitor voucher or pay to park when parking in the area during the hours of operation.

Warning notices will be issued to vehicles parked in the area without a permit between the 3-9 October 2018.

Street parking suspension dates

Please see the table below for planned dates of when parking in your street and surrounding streets will be suspended while lining works are carried out.

It's important to be aware that motorists will not be able to park on the streets during the dates specified below **(roads will only be suspended between 8am and 4pm on the dates below and will not be suspended on weekends)**. Signs will be erected on each street to inform motorists of the dates of the lining works.

We aim to complete these works as quickly as possible. To ensure that we can do this, please help us by moving your vehicle to an alternative street where works are not taking place. Once we have completed the lining works on a section of road, the yellow suspension signs will be removed so that parking on the street will be available again as quickly as possible.

Be aware that vehicles parked in suspended bays may be issued with a PCN and removed to allow us to complete our planned works. Drivers who suspect their vehicle has been removed should contact TRACE on 0300 077 0100.

***Suspensions dates may be subject to change due to a number of factors beyond our control. This includes weather and whether or not roads have been kept clear of vehicles for works to be completed. Please check the yellow signs affixed to lamp columns in the area for the most up to date information.**

Parking in nearby zones during implementation

In order to provide you with alternative parking opportunities whilst lining works are taking place, you will be able to use your zone U e-permit to park in existing zones R or T, so that you don't have problems finding somewhere to park when your roads are suspended for lining works.

In order to benefit from this, please ensure that you select the earliest available permit start date when applying – from this date until your new zone goes live you will be able to park in zones R or T while lining works are carried out. Depending on the duration you bought, we will then extend your zone U e-permit to give you a full three, six or 12 months of parking from your new zone's start date at no extra cost to you.

Your permit will only be valid in zones R and T until your zone goes live on Monday 15 October 2018. Please ensure that you do not park in these zones after your parking zone goes live as you may be issued with a PCN. Zone U visitor vouchers will not be valid in zone R or T at any time.

A map is enclosed with this letter of zones R and T where your zone U permits will be valid to park until Sunday 14 October 2018.

Applying for permits and vouchers

You will need to have a valid permit or vouchers to park in zone U when the zone goes live. You can apply now for these online hackney.gov.uk/resident-permits or by post.

Choosing your permit start date: When applying, please ensure that you select **the earliest available start date** – from this date until your new zone goes live you will be able to park in zones R or T while lining works are carried out. Depending on the duration you bought we will then extend your zone U e-permit to give you a full three, six or 12 months of parking from Monday 15 October at no extra cost to you. There will be no change to e-permits bought on or after the Monday 15 October 2018.

Be aware that permit start dates cannot be altered once they have been chosen and an application has been made. Full refunds will be made if they are cancelled before their start date. E-permits cancelled after the start date are payable for each full calendar month remaining on the permit from the date we receive your refund request. There must be a minimum of three months remaining on the permit and you will need to pay a £20 administration fee.
