Extension of Zone U parking controls

Parking Services consulted all residents and businesses in the Parking Zone U displacement area about proposals to introduce parking controls. Following this consultation the Council has made the decision to implement parking controls on all roads within the Zone U displacement area.

This letter provides details of the dates we will be marking out the parking restrictions on your road and when enforcement of these restrictions will begin.

How will the change affect me as a resident?

All streets within the Zone U displacement area will be incorporated into the existing Parking Zone U (Upper Clapton). These streets will also adopt the same operational hours of Zone U, which are currently **Monday - Saturday 8.30am to 6.30pm**.

All vehicles will need to have a valid ePermit in order to park on Zone U roads when parking enforcement commences.

Key facts

Purchasing of permits can commence from:	14 October 2019 – You can start applying for your permit a month in advance of the go live date. Please see ‘Applying for Permits and Vouchers’ section below for further information.
Temporary parking restrictions during lining works:	14 October 2019 to 1 November 2019 For the duration of the lining works please use the enclosed <u>Temporary Implementation Permit</u> to park in Zone U. The permit will allow you to park in any on street resident, permit and shared use bays within the zone (please see attached terms and conditions). Your temporary permit will only be valid for the period of 14 October 2019 to 1 November 2019 . <u>Please note, this permit is only valid in existing Parking Zone U, It cannot be used to park on suspended roads during lining works.</u>
Permit start dates:	11 November 2019 - This is the start date of your permit. Please ensure that you enter this date when applying for your permit online.
Parking enforcement on the parking bays commences:	11 November 2019 You must have a valid Zone U e-permit to park in your zone from this date.
Yellow line enforcement	All <u>existing</u> and <u>new</u> yellow lines within the zone will be enforced during and after the lining works are completed. Please ensure you do not park on any single or double yellow lines or you may be issued with a Penalty Charge Notice (PCN).

Signage during lining works

Yellow signs will be erected to inform motorists of the dates when the lining works are taking place. You must not park on these roads on the dates shown, these signs will be removed once the work is completed so that parking is available again as quickly as possible. **(Please note, lining works will only be carried out between 8am and 4pm on the dates below. No works will be carried out during weekends).**

IMPORTANT

To help us ensure that we can complete these works as quickly as possible, please move your vehicle to an alternative street in Zone U (using your Temporary Implementation Permit) or to the section of the road where works are not taking place.

Vehicles parked in the above areas during the specified dates may be issued with a PCN and relocated.

Drivers who suspect their vehicle has been relocated should contact TRACE on 0300 077 0100.

Please note that dates of planned lining works may be subject to change due to a number of factors beyond our control. This includes weather conditions and whether or not roads have been kept clear of vehicles for works to be completed. Please

check the yellow signs affixed to posts and lamp columns in the area for the most up to date information.

Parking in nearby zones during implementation

In order to provide you with alternative parking opportunities whilst lining works are taking place, you will be able to use the Temporary Implementation Permit (attached) to park in Zone U (enclosed map) between **14 October 2019 to 1 November 2019**. Please ensure that you do not park in Zone U after this date using the Temporary Implementation Permit, as you may be issued with a PCN.

The Temporary Implementation Permit cannot be used in any suspended roads during the lining works. **It is only valid in existing Parking Zone U.**

Applying for permits and vouchers

You will need to have a valid parking permit or voucher to park on the street when the scheme goes live on 11 November 2019. You can apply for these online hackney.gov.uk/resident-permits or by post from 14 October 2019.

If you wish to park your vehicle on existing Zone U roads during the lining works please ensure that you use the Temporary Implementation Permit between 14 October 2019 to 1 November 2019 only.

Permit start dates cannot be altered once they have been chosen and an application has been made. Full refunds will be made if they are cancelled before their start date. E-permits cancelled after the start date are payable for each full calendar month remaining on the permit from the date we receive your refund request. There must be a minimum of three months remaining on the permit and you will need to pay a £20 administration fee.

Go live date

Parking enforcement on parking bays within the Zone U displacement area will begin from **Monday 11 November 2019.**

From this date, all vehicles will need to display a valid e-permit or valid visitor voucher when parking in the estate.
