Re: Zone U Review Consultation Implementation

Following on from the publication of the Zone U Review summary outcome, Parking Services have completed the statutory consultation for the zone and will now be proceeding with the implementation of the recommendation to change the current operational hours to **Monday to Friday 10.00am - 12.00 (noon)** on the roads mentioned below and implement parking design changes as per the review recommendations.

Parking Restrictions Implemented

Lining and sign changes in the zone will take place on the week commencing **30 May 2022**. During this time, we will put in place parking suspensions in order to carry out the works. Suspension signs will be erected on site a minimum of 5 working dates before the start of the suspension to inform you of the dates of the lining. Please be advised that any vehicles parked within the suspended bays may be issued a PCN. During the implementation process, there will be minimal impact to residents as their permits will continue to be valid in both sections of Zone U.

Go Live

The changes to the operational hours in the Zone U subzone will commence from **30 May 2022**. Please ensure you adhere to all sign changes from **30 May 2022**.

How will the new change in operational hours affect me?

Residents and businesses with an existing Zone U parking permit will not need to do anything, the current Zone U permit can be used as normal to park during controls in both the northern and southern section of the zone.

Visitors parking on roads with the shorter hours of **Monday to Friday 10.00am - 12.00 (noon)** will only be required to either park in pay and display and shared use parking bays or display visitor vouchers during these hours. In roads with the hours of **Monday to Saturday 8.30am to 6.30pm**, parking sessions will be required for the whole day.

If residents in the northern section of Zone U have any books of full unused undamaged one day visitor vouchers and would like to return these, Parking Services will replace these for a book of 2hr vouchers free of charge. Please return these vouchers, along with a cover letter containing your name and address to:

All requests have to meet the above criteria and be received no later than **30 September 2022**. Please note that your all day vouchers will still be valid in the zone where the longer hours are being maintained.
