# **Introduction**

Hackney Council carried out a 12 week consultation to determine whether a Cumulative Impact Assessment (CIA) should be published for Shoreditch and Dalston.

A CIA helps to manage the number and type and density of licensed premises within an area. Licensed premises include places which sell alcohol, provide late-night hot food or hot drinks (between 11pm and 5am), or where a range of sporting, music or performance events take place.

A CIA would only apply to new licensing applications. Existing licences would not be affected.

# **Background**

Last year, Hackney Council commissioned Six Till Six and MAKE Associates to conduct research to establish if the number or density of licensed premises in Hackney is having an adverse 'cumulative impact' on crime and disorder, public safety, public nuisance or protecting children from harm.

This included interviews and a research survey to capture the views of residents, businesses, visitors, those that work in the borough and any other interested parties.

#### **Cumulative Impact**

Cumulative impact is the term used to describe the effect that having a number of licensed premises in a concentrated area can have on the four licensing objectives which are:

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

The cumulation of licensed premises can have a disproportionate demand on local services such as transport, public lavatories, waste collection and street cleaning. There may also be a higher level of crime and disorder, often associated with alcohol related violence that can take place which will draw in additional demands on the police as well as the ambulance service.

# **Consultation & Engagement Approach**

The consultation was created and published on Citizen Space, the Council's survey platform, and was live from 29 July until 20 October 2024.

Communications were sent out via social media and Love Hackney, with promotion via the Hackney CVS newsletter.

A Pubwatch meeting was attended in Shoreditch.

We also consulted with the persons set out in section 5(3) of the Licensing Act 2003, namely:

- the Chief Officer of Police
- the London Fire Brigade
- Public Health
- holders of premises licences
- holders of club premises certificates
- holders of personal licences
- other persons considered to be representative of businesses and residents in the area

A discussion was also carried out at the Shoreditch Pubwatch on 2nd October 2024 and Dalston Ward Forum on 16th October 2024. A short summary can be found at the end of the "Overview of results" on page 16.

# Response rate

A total of 77 respondents took part in the consultation.

# **Executive Summary**

Hackney Council conducted a consultation to gauge public opinion on implementing Cumulative Impact Assessments (CIAs) in Shoreditch and Dalston. The consultation received responses from 77 participants, primarily Hackney residents and owners/managers/employees of licensed premises.


Regarding Shoreditch, most respondents supported the CIA, citing negative impacts of alcohol-licensed premises. However, concerns were raised about potential economic harm to businesses, cultural erosion, displacement of social issues, negative perception, and limited community involvement. There was disagreement on exempting small restaurants from the CIA, with concerns about potential loopholes and enforcement challenges.

In Dalston, the majority also agreed with the CIA, but with strong concerns about potential negative effects on small businesses, the local economy, and the area's cultural vibrancy. Feedback from the Dalston Ward Forum and Shoreditch Pubwatch echoed these concerns, emphasising the potential harm to the nighttime economy and the need for greater community engagement in the decision-making process.

The consultation also gathered demographic information about respondents, including gender, age, disability status, caring responsibilities, ethnicity, religion, sexual orientation, and housing tenure. This data provides additional context for understanding the diverse perspectives within the community. Overall, the consultation revealed a complex landscape of opinions and concerns surrounding the implementation of CIAs in Shoreditch and Dalston. While the majority supported the assessments, there was a clear need to address the potential negative impacts on local businesses, the economy, and cultural identity. The feedback highlighted the importance of community involvement and careful consideration of the unique characteristics of each area when developing and implementing such policies.




The majority of respondents stated that they were a "Hackney resident", accounting for just over three quarters (58). Just over 18% stated they were an "owner/manager/employee of a licensed premises" (14). All others accounted for a much smaller percentage of respondents.

# To what extent do you agree or disagree with the proposal below to publish a CIA for Shoreditch? (Base 74)

Hackney Council is proposing to publish a CIA for Shoreditch based on the evidence from the review carried out by Six Till Six Ltd and Make Associates. The analysis showed that there is a negative impact associated with alcohol licenced premises in Shoreditch (former Special Policy Areas).



The majority of respondents, at just under three quarters, agree with the proposal to publish a CIA for Shoreditch (54), with just over a quarter who disagree (19). Only 1 respondent stated they were not sure.


# Negative Impact on Residents

#### To what extent do you agree or disagree with the proposal below? (Base 74)

Hackney Council considers that any CIA applying to Shoreditch would not be applicable to small restaurants (no more than 50 covers) operating no later than 23:00 weekdays and 00:00 at weekends.



The majority of respondents stated that they disagree with the proposal (39), but this is not significantly different from those who stated that they agree (33). Only 2 respondents stated that they were not sure.

#### If you strongly disagree or disagree, can you tell us why? (33 comments)

- Impact on Local Community and Economy
  - Description:
    - Concerns about how the early closure of small restaurants might harm the local economy, vibrant nightlife, and community appeal.



Hackney Council is proposing to publish a CIA for Dalston based on the evidence from the review carried out by Six Till Six Ltd and Make Associates. The analysis showed that there is a negative impact associated with alcohol licenced premises in Dalston (former Special Policy Areas).

The majority of respondents, at just under two thirds, agree with the proposal to publish a CIA for Dalston (47), with just under a quarter who disagree (19). 8 respondents stated they were not sure.

#### If you strongly disagree or disagree, can you tell us why? (29 comments)

- Regulation and Licensing



The majority of respondents, at just over 50%, stated that they agree with the proposal (37), but this is not significantly different from those who stated that they disagree (31). 5 respondents stated that they were not sure.

#### If you strongly disagree or disagree, can you tell us why? (26 comments)

- Regulation Loopholes and Enforcement

#### **Dalston Ward Forum Feedback**


The ward forum was productive, with good attendance from residents, local councillors, and business representatives. The discussion was insightful, though there was a noticeable lack of enthusiasm for publishing a CIA for Dalston. Some residents were unaware of the absence of a SPA, with isolated issues like ASB in Gillett Square being a bigger focus than cumulative impact. The higher crime rates during the day compared to night were mentioned several times.

#### Shoreditch Pubwatch Feedback


The general consensus during the session was that publishing a CIA would be detrimental to the night time economy and the area as a whole. Attendees cited a significant decrease in footfall in recent months. There were also some suggestions that the field research was undertaken during a period of heightened post pandemic revelry which has skewed the findings. Overall, the group did not feel that a CIA applying to Shoreditch would be appropriate.

#### Gender: Are you....(Base 77)






#### Are you transgender or do you have a history of being transgender? (Base 77)

Age: what is your age group? (Base 75)




The highest percentage of respondents were in the 35-44 age group (24), followed by 45-54(16), 25-34 (15), 55-64 (13) and 65-74 (7).




Disability: Do you consider yourself to be disabled? (Base 75)

# Caring responsibilities: Do you regularly provide unpaid support caring for someone? (Base 74)




The majority of respondents stated that they do not have caring responsibilities (66). 8 respondents stated that they do.




Ethnicity: Are you.... (Base 75)

#### Religion or belief: Are you or do you have... (Base 74)




The majority of respondents stated that they were "Atheist/no religious belief" (49), followed by "Christian" (17). All others accounted for a much smaller percentage.
